Discussion of Goshen Bicentennial to be Celebrated in 2019

Bob Haas presented a marketing packet and fundraiser ideas donated by Natasha and Tyler Bailey of Wage War Apparel. There has also been interest in 2.5 inch commemorative coins. Mr. Haas presented t-shirt mockups to the board, as well as banners to place at busy intersections to peak interest. Mr. Haas stated he will be taking the design to the Goshen Historical Society for their approval. He has a donor for 2 banners.

Trustee Allen asked if the shirts would have more pictures than the banner mockups. She requested consistency for all marketing materials. Trustee Hausermann liked the plane and baseball reference. Trustee Hodges stated he liked the designs that were simpler. He suggested the schools have a place on the main design as well.

Mr. Haas stated he is going to look into dinner at the O'Bannon Creek Golf Course, but there is a question of placing a deposit, since there has not been any fundraising. Trustee Hausermann suggested using the line item for Community Contributions if necessary to help secure the deposit. He suggest the bicentennial committee provide the Board of Trustees an itemized list of requests.

Trustee Hodges stated that two of his carnival contacts are unavailable, but he will still be searching. Mr. Haas stated that the circus tickets will be very reasonably priced. Donna Rosic of the Lion's Club stated it is the Kelly Miller Circus.

Mr. Haas stated that there has been a lot of interest in a cruise in. Trustee Allen stated Jimmy Allen is interested in helping with a cruise in or car show.

Mr. Haas stated that he is looking into a weekend in July for a big Hoorah, and that they have received a commitment from the Cincinnati Red Legs for an 1869 baseball game next to the log cabin. They are hoping to have a festival, rides, ice cream social, class reunion, and inflatables. A master schedule is in process. He will be discussing with Holtman's a commemorative donut special. There was also a discussion of adding the bicentennial to the Memorial Day Parade next year that the Chamber holds.
